We are moving to i-Connect

Worcestershire Pension Fund will be transitioning to a monthly data exchange via i-connect, this means all Employers will need to supply monthly membership data via a CSV file upload or by manually completing an online return within the i-connect portal.

You should have received an email with <u>an</u> <u>information poster</u> highlighting the key changes and how this will impact the way you communicate with the Fund.

Outsourcing of Contracts and Academy Conversions

Our process for moving members between employers can only start following a **formal request** from the outsourcing / letting employer or the school converting to academy status to move the employees in question to another LGPS employer.

Notification of such information is a statutory duty and responsibility on the outsourcing / letting employer or school under the LGPS Regulations.

If such a request is not made before the employees switch employer, their LGPS membership will be associated with the wrong employer, making it difficult for us to collect contributions or to retire an employee or to deal with a death in service.
