REMINDER: Any employers onboarded onto i-Connect before 31 March 2025 do not have to complete a Year End Return as this will be included in your April submission.

Automatic Enrolment Earnings Bands 2025/26

Please be informed of the earnings bands applicable for the 2025/26 period concerning automatic enrolment under the Pensions Act 2008. The UK Government has confirmed in its review of the automatic enrolment earnings trigger for 2025/26 will remain at £10,000, unchanged since the 2014/15 year. The tables below provide detailed information for the 2025/26 year.
